#### 1 Introduction

Following the publication of the Government's Eco-town Prospectus in July 2007, which invited developers and local authorities to come forward with expressions of interests on suitable locations and proposals for eco-towns, Parkridge put together a submission proposing a potential site near Weston on the Green in Oxfordshire.

Parkridge wanted to gain feedback from the community on its draft proposal so engaged the services of Mistral – a locally-based communications consultancy with a track record of award-winning community engagement projects – as specialists in such activity to undertake consultation for Weston Otmoor. The report that follows is a report on the consultation activities.

In addition to public consultation activities, Parkridge is committed to working closely with local authorities and stakeholders and employed the services of Connect Public Affairs – an award-winning, strategic public affairs company – to undertake these tasks.

This report summarises the activities that took place between Monday June 23, 2008 and Friday August 29, 2008 and feedback received. This first phase of consultation forms the precursor to further stakeholder and community involvement in the development of the proposal in the event Weston Otmoor is selected by Government in its shortlist, expected early in 2009.

Summary data tables from all consultation activities are included within the document.



## 2 Consultation plan overview

In order to comprehensively engage the public in Parkridge's plans for Weston Otmoor, Mistral researched and wrote a communications strategy document. This document was submitted to the Department of Communities and Local Government (CLG), Cherwell District Council (CDC) and Oxfordshire County Council (OCC) for their comments and input, all of which were incorporated into the final strategy.

The strategy included key recommendations for community engagement and related activities, as well as supporting media activity.

The following objectives were identified:

- Stakeholders are identified and attitudes are tracked
- Communities understand the process, get the facts they need to evaluate the proposals firsthand and are able to feed back their comments and suggestions
- Support and opposition are captured and put into context
- Issues are identified which can be tackled at the design stage
- Misinformation in the media is corrected.

Activities undertaken to reach these objectives included:

#### Mapping existing community and faith organisations

Mistral undertook research to identify existing local groups, governance structures and communications matrices that exist in communities within the proposed settlement's sphere of influence. By utilising these existing communications routes, Mistral was able to successfully engage key players and residents within local communities. Identified groups included: youth, business, historical and preservation, social, voluntary, schools, and church groups. Where possible, Mistral also worked with parish councils to utilise existing channels such as village notice boards.

#### Consulting with commuters

As transport is a key element of the Weston Otmoor proposal, both to support residents and ease pressure on already burdened commuter routes in the local area, it was considered important to ascertain the views of the commuter community on how the proposals will affect them. The community newsletter was used for a leaflet drop at the Peartree 'Park & Ride' to the north-east of Oxford and distributed at Oxford train station. This introduced the proposals to the commuter community as well as local residents who travel in and out of these busy centres, and invited them to share their views.



#### 3 Pre-consultation communications

Following the publication of the Eco-town Prospectus in July 2007, Parkridge has been keen to establish productive relationships and open dialogue with the two local authorities – Cherwell District Council and Oxfordshire County Council.

Contact with members and officers from both local authorities has been wide-ranging over the past year, and would be difficult to detail in full. However, the following provides an overview of the key meetings and the working relationship which has been established between the two local authorities and the Parkridge project team.

- Early exploratory meetings and briefings took place in advance of the expression of interest being made by Parkridge to the Department of Communities and Local Government in October 2007
- Following the release of the eco-town short-list in April 2008, a technical working group including representatives of the local authorities and Parkridge was established to allow the local authorities to assess the proposals and to request further information and seek clarification from Parkridge
- Advice and recommendation was sought from both local authorities as Parkridge's community consultation strategy was devised. This included sending a draft of the strategy to both local authorities for their comments and approval
- Information regarding the eco-town proposals and forthcoming consultation activity was sent
  to all local stakeholders and a consultative forum, bringing together representatives from the
  local authorities, parishes and other stakeholder groups, was formed
- Parkridge has attended workshops and provided information to facilitate and assist the South
  East of England Development Agency's study which is being undertaken on behalf of the local
  authorities into the potential impact of the eco-town proposals on Bicester.

Parkridge has offered to meet with all representative bodies of local Government in the region including ten parish councils and Bicester Town Council, as well as the relevant district and county councils, to provide their members with a detailed understanding of the proposals and the opportunity to ask questions and for clarification. Parkridge has been keen to ensure that elected representatives have the necessary and correct information to answer any questions that may have been asked of them by their constituents. The following bodies have accepted the invitation to meet and meetings have subsequently taken place:

## 4 Publicity

The confidential and indeed very conceptual nature of the proposed eco-town prior to the short-list being announced made meaningful proactive communication by Parkridge extremely difficult. As a result, the communications 'void' had, prior to the consultation, been filled by vocal opponents and conjecture based on out-of-date information leaked to the local press.

The following activities were used to announce the launch of, and timetable for, the consultation, using a range of channels to ensure maximum awareness and encourage participation. All publicity included the consultation timetable, the roadshow schedule, website and email address, and community hotline telephone number.

- Media relations (press releases issued and copies of resultant coverage can be found in appendices 1 and 2 respectively)
  Mistral worked with its established contacts in the local media to publicise and communicate the launch of the consultation and its timetable, and the various ways in which people could respond. This resulted in several pieces of print, broadcast and online media coverage, with the following titles publicising details of the consultation: Bicester Advertiser, Bicester Review, Oxford Mail, Oxford Times, BBC Radio Oxford and Fox FM
- Advertisement (a copy of the advertisement/poster can be found in appendix 3)
   Full colour quarter page advertisements were placed in the most-read titles for the area surrounding the proposed development site: Banbury Cake, Banbury Guardian, Bicester Advertiser, Bicester Review, Brackley and Towcester Advertiser, Bucks Herald, Buckingham Advertiser, Oxford Mail and Oxford Times
- Poster (a copy of the advertisement/poster can be found in appendix 3)
   A4 colour posters were displayed in each village or town hosting a roadshow. Parish and post office notice boards were identified as the hub of community communications and were therefore utilised where possible
- Letters of invitation (a copy of the letter can be found in appendix 4)
   Using the mapping of local communities research, letters were sent to identified local groups, organisations and Governmental structures not already contacted by Parkridge / Connect
   Public Affairs, inviting them to attend one of the 17 consultation roadshows



## Newsletter

40,000 newsletters were distributed, presenting basic facts about the proposals, and encouraging people to give their feedback. This also included a reply pre-paid questionnaire. See Section 5 for more details.



#### **5** Community newsletter

The newsletter served as both a publicity and consultation channel, containing details of the proposal and a feedback route in the form of a reply pre-paid questionnaire.

In order to reach as many stakeholders as possible and to ensure they received accurate information about the consultation and proposals first-hand, 40,000 six page colour newsletters were produced and distributed. The newsletter was titled 'A Sustainable Future' and provided information on the background to eco-towns and the Weston Otmoor proposals; the current masterplan with annotations; a quantitative reply-paid questionnaire; details of the channels through which people could submit their feedback; information on the eco-town process; and a calendar of the 17 roadshows taking place across the surrounding area. A copy of the newsletter can be found in appendix 5.

Unfortunately Cherwell District Council would not permit the use of its full electoral role for the purposes of consultation for Weston Otmoor; therefore a commercially-available edited version was used to distribute the newsletters. As well as distribution by post, newsletters were handed out to commuters at Peartree Park & Ride, Oxford Railway Station and to commuters travelling from Bicester North to London Marylebone. This provided the opportunity for those currently using rail and bus links, and therefore potentially affected by transport links provided by Weston Otmoor, to view the proposals and give their feedback on Weston Otmoor.





#### 6 Consultation website

A dedicated consultation website was established and will be maintained for the lifetime of the project. During the consultation period, the website provided details of the proposals. In addition, visitors to the website were able to complete two online questionnaires to give their feedback on the proposals.

The website had a wide geographic reach, with people registering and submitting their comments from areas including Wiltshire, Maidenhead and Hereford.

The content for the website was designed to educate people first-hand about the proposals for Weston Otmoor as they stood at that time. The pages reflected the information provided at the roadshows, and was the basis for the consultation and feedback. The questionnaire included in the newsletter was uploaded onto the website, allowing people to register their views online, and thus opening up the consultation to the wider public and providing choice on how to submit comments.

In addition to the newsletter questionnaire, which was quantitative, the more qualitative roadshow questionnaire was also uploaded onto the website. This then provided people with the opportunity to register more detailed comments if they were unable to attend a roadshow or hadn't already submitted comments via email or telephone.

In total, 172 people registered to use the site. Of those registered users, 68 people (39.5 per cent) completed the online version of the newsletter questionnaire, and nine users (5 per cent) completed the roadshow questionnaire.



Question 1 of the questionnaire asked respondents to provide their postcodes. A majority of respondents to this questionnaire are based in Oxfordshire.



During the course of the consultation, a dedicated telephone number was set up to provide an alternative route for people to submit their comments. Calls to this number were received by members of the Weston Otmoor community team at Mistral.

For many callers, this was the first opportunity they had had to speak to someone directly involved in the Weston Otmoor project. The majority of calls were received in the first two weeks following the distribution of the newsletter, with the call rate decreasing gradually as the roadshows began.

In addition to the telephone line, a dedicated email address was set up. People submitting their comments received an automated response thanking them for their input (see appendix 7). In total 44 telephone enquiries were received and 41 emails.

A very small number of people (four) opted to send letters to voice their concerns and objections, which included: pressure on existing infrastructure and also on that proposed in the town; concerns about the revised junction nine plans; fears the eco-credentials are not true; the negative effects on Bicester; and worries that Weston Otmoor will be a gated town.

A summary of all the feedback logged via the telephone and email channels is on the following page.

## 8 Community roadshows

A series of 17 community roadshows was organised within the sphere of influence of the proposed development site. The roadshows took place during a three-week period to ensure stakeholders were engaged within a short timeframe and therefore received information in a timely and unbiased manner.

Destinations for the roadshows were chosen due to their proximity to the proposed development site as well as their well-formed and active communities, with input from both local authorities. Well-known venues central to community life (such as village halls and schools) were chosen to ensure accessibility, and the events were held prior to the school holidays to ensure maximum availability of community members.

The roadshows presented ten A1 exhibition boards, detailing the proposals as they were at that time, as well as background information to the eco-town process (copies of the boards can be found in appendix 8, and appendix 9 shows the boards in situ). In addition, literature provided by CLG gave more detailed information on the eco-town process. A qualitative roadshow questionnaire was distributed to visitors to provide a channel through which to provide comments on the proposals and note any additional questions. The roadshows were manned by members of the Mistral community relations team. As the roadshow questionnaires were left intentionally anonymous, people were able to fill in a further form to supply either postal or electronic contact details to receive further information on the proposal when it became available.

Note: A previously confirmed and advertised presence of the Weston Otmoor consultation roadshow was at Bicester Carnival. This presence was suggested and confirmed by Bicester Town Council as an event that would be attended by a range of age groups from miles around. However, following a meeting of the full town council, the decision was made to retract the offer of space for the Weston Otmoor consultation as it felt that the carnival was not an appropriate venue.



#### 9 Conclusions and considerations

#### **Consultation response**

There was a good response to the consultation overall, with respondents using all the feedback channels available:

- The community newsletter received the highest level of response, with 2927 questionnaires returned
- 1481 attended the roadshows of whom 634 returned completed questionnaires, and a further nine were completed online
- The consultation website has 172 registered users of whom 68 completed questionnaires.

Responses to the community newsletter were not particularly high – the eco-town initiative has attracted much national publicity so a very high response rate was anticipated. The maximum response rate that can usually be expected for a newsletter is around 5%; the actual response rate of 7.3%, which while on the face of it is quite high, actually shows a high degree of disinterest from the majority of the community given the large scale and potential impact of the proposals.

Similarly, visitor numbers to some of the exhibition roadshows were very small with only an overall average of 9.8% of the combined population of the 14 surrounding villages attending. Again, this is higher than the average turn-out rate for other consultations but is much lower than anticipated given the controversial nature of the proposals.

Overall, in an area where the opposition to the proposed Weston Otmoor eco-town is purported to be universal, an even higher level of participation – and opposition – might have been expected. This suggests that there is an as yet untapped body of local respondents who have no strong views on the proposal.

#### **Feedback channels**

Almost double the number of respondents through all three channels found their chosen feedback route more useful than those who did not find it useful, with the website rating highest and the roadshow lowest in terms of usefulness:

- **Newsletter:** 61.2% found it useful (23.8% very and 37.4 % quite) compared with 31.3% who found it not very or not at all useful. 7.5% did not answer
- **Website:** 66% of respondents found it useful (32% very and 34% quite) compared with 33% who found it not very or not at all useful
- **Roadshow:** 50.6% of respondents found it useful compared with 27.4% who did not find it useful. 8% did not know and 13% did not answer.



As responses from all routes were deliberately kept anonymous, it is impossible to say how many responses were from distinct individuals or individuals using multiple routes. The data has therefore been analysed according to response channel and not amalgamated.

#### **Newsletter questionnaire analysis**

There was a high level of awareness of the proposals among respondents, 83.3%, before the consultation started.

- 35.6% of respondents did not accept the need for more housing in the area
- 31.8% accepted the need for more housing in the area, but not at Weston Otmoor
- 19.9% accepted the need for more housing in the area and agreed that Weston Otmoor was as good a place as any.

Breaking this down further, it is interesting to see the changing attitude towards the need for more housing in the area, and how it varies between geographical areas. Bicester and many of its surrounding villages, for example, show the largest portion of respondents stating there is no need for more housing in the area. Oxford and a number of neighbouring settlements, on the other hand, agree more housing is needed but not at Weston Otmoor.

The majority of respondents to the newsletters travel regularly by car, 44.3%, with the majority of journeys, 28.5%, being under 10 miles and 16% between 11 and 20 miles.

There was strong agreement that the area needs improved infrastructure:

- 71.8% agreed that 'an enhanced A34/M40 junction is already necessary to cope with existing traffic'
- 61.8% agreed that 'public transport links around Bicester and the local area need to be improved'
- 60.3% agreed that 'an East West Rail Link would benefit Bicester and the local area'.

There was disagreement with infrastructure aspects associated with the Weston Otmoor proposals:

- 53.5% of respondents disagreed that 'an extra Park & Ride at Weston Otmoor will help existing A34/M40 traffic congestion'
- 70.4% disagreed with the statement that they 'would be likely to use the new Park & Ride'
- 45.1% disagreed that they 'would be likely to use the East West Rail Link'
- 41.3% disagreed with the concept that there should be only one access/exit route directly connecting onto a new A34/M40 junction to limit car use
- 59.8% disagreed that this access/exit road should be a toll
- 57.3% disagreed that this toll should vary depending on how busy the A34/M40 junction is.



Overall, 73.6% of respondents believed that the surrounding towns and villages would not benefit from an eco-town at Weston Otmoor, compared with 16.11% who did. 8.1% neither agreed nor disagreed and 2.1% did not respond.

The biggest concerns with regard to building an eco-town at Weston Otmoor were:

- 27.5% of respondents cite damage to greenfield, green belt, wildlife, SSSI
- 18.5% cited traffic/congestion/transport
- 8.5% cited damage to the surrounding area (communities and towns and villages)
- 8% were concerned by the size and location of the proposals
- 5.9% said they had no concerns
- 6.4% did not state their concerns.

Looking at the breakdown of results by postcode, a pattern can be seen whereby those living closest to the proposed site of Weston Otmoor are least likely to accept either the need for more housing in the area, and that Weston Otmoor is as good a place as any:

- More than 40% of respondents in postcodes OX14, OX25, OX26, OX27 and MK14 do not accept the need for more housing in the area
- Over 40% of respondents from postcodes OX20 and OX33 accepted the need for more housing in the area, but not at Weston Otmoor.

Those living in the postcode immediately closest to the site, OX25, are the least likely to support the proposal with only 8.8% accepting the need for more housing in the area and thinking that Weston Otmoor is as good a place as any.

Similarly, the further afield from the site the more likely it is that that Weston Otmoor is identified as a good a place as any for new housing, with over 40% of respondents in OX1, MK13 and MK14 registering support, although the response rate from these postcodes is typically lower than from postcodes in the immediate vicinity.

#### Website questionnaire analysis

94.1% of online respondents were aware of the proposals before the consultation started, reflecting that this was a self-selecting audience who specifically visited the website to find out more about the proposals and complete questionnaires.

- 36.8% of respondents accepted the need for more housing in the area, but not at Weston Otmoor
- 29.4% of respondents did not accept the need for more housing in the area
- 26.5% accepted the need for more housing in the area and agreed that Weston Otmoor was as good a place as any.



The majority of respondents to the online questionnaire, 68%, travel regularly by car, with the majority of journeys, 38%, being under 10 miles and 18%, the next largest response category, being over 50 miles.

Online respondents agreed strongly that the area needs improved infrastructure:

- 74% agreed that 'an enhanced A34/M40 junction is already necessary to cope with existing traffic
- 67% agreed that 'public transport links around Bicester and the local area need to be improved'
- 62% agreed that 'an East West Rail Link would benefit Bicester and the local area'.

There was disagreement with infrastructure aspects associated with the Weston Otmoor proposals:

- 70% disagreed with the statement that they 'would be likely to use the new Park & Ride'
- 59% of respondents did not agree that 'an extra Park & Ride at Weston Otmoor will help existing A34/M40 traffic congestion'
- 35% disagreed that they 'would be likely to use the East West Rail Link'.

There was slightly higher agreement than disagreement, 39% compared to 36%, that the eco-town should have one access/exit route, although there was 47% disagreement that this should be a toll, and stronger disagreement at 57% that the toll should vary according to congestion.

Overall, 69% of online respondents believed that the surrounding towns and villages would not benefit from an eco-town at Weston Otmoor, compared with 20% who did, while 10% neither agreed nor disagreed.

The biggest concerns among online respondents with regard to building an eco-town at Weston Otmoor were similar to those expressed by those completing the pre-paid reply questionnaires: destruction of greenfield sites and effect on wildlife; traffic and congestion; and location. Concerns were also expressed over the quality of housing, and that this would be a commuter town.

Online respondents felt the biggest benefits Weston Otmoor would bring to the local area were jobs, schools and high standards of housing (including a provision of affordable).

Overall, there were some differences between responses received to the online versus the pre-paid questionnaires: there were higher levels of those regularly travelling longer distances by car and overall support for a single access point for the eco-town, suggesting that longer-distance commuters believe that this would be a useful measure to limit congestion. Online respondents were more likely to accept the need for new housing in the area and agree that Weston Otmoor was as good a place as any, 26.5% compared with 19.9%, and were more likely to believe that the surrounding towns and villages would benefit from an eco-town at Weston Otmoor, 20% compared with 16.11%.



#### **Exhibition questionnaire analysis**

Overall, 86% of respondents disagreed with the proposals for Weston Otmoor, 82% strongly, with 10% agreeing with the proposals and 4% neither agreeing nor disagreeing. Looking at this pattern of support by village or town visited, although this is indicative only as this is a mobile community with residents of some villages attending roadshows in neighbouring villages and very low attendance figures at some roadshows, as might be expected, the negative response was highest in those closest to the proposal:

- Middleton Stoney and Islip at 100% disagreement
- Kirtlington at 97% disagreement and 3% agreement
- Chesterton at 96% disagreement and 4% undecided
- Charlton Otmoor at 94% disagreement and 3% undecided with 3% not responding
- Weston on the Green at 92% disagreement, 4% agreement with 1% undecided and 3% not responding
- Bucknell at 90% disagreement and 10% undecided
- Wendlebury at 88% disagreement, 6% agreement and 6% undecided
- Bletchingdon at 86.5% disagreement and 13.5% agreement
- Marsh Gibbon at 85% disagreement, 7% agreement and 7% undecided.

The results from Ardley are notable, showing the lowest level of disagreement at 56% (although not the highest level of support) and the highest level, 31%, of respondents undecided.

The highest level of support, 34%, was recorded at the Ambrosden roadshow, followed by 33% at Steeple Aston.

Responses from roadshows held in the larger conurbations – Kidlington, Bicester and Oxford – although overall in disagreement with the proposals, respectively 64%, 79% and 70%, did show higher levels of support than typically seen in individual villages. Bicester and Kidlington both showed 14% agreement with the proposals, rising to 25% in Oxford. This higher level of support is not unexpected, as all three are more distant from the immediate sphere of influence of the proposals.

Concerns highlighted among respondents to the roadshow questionnaires are similar to those cited by respondents to both the online and pre-paid questionnaires, with traffic and congestion, and destruction of the countryside and/or the SSSI. Concern was also expressed over flooding, a decrease in local property prices and an increase in the local population and that Weston Otmoor would destroy the rural character of the area.

Benefits of the proposals cited by visitors to the roadshows included affordable and much-needed housing, jobs, improved infrastructure including a rail link and an improved Junction 9 of the M40,



and the opportunity for a mixed age range in the population, rather than the older profile which is currently the case.

A range of facilities that could be included in the Weston Otmoor eco-town were suggested by some respondents to the roadshow questionnaire, such as provision for the elderly and healthcare, sports and entertainment facilities including a library and a cinema, with these facilities being open to the surrounding population. This suggests that some members of the local community are aware that they can have a role in shaping benefits for their local community arising from Weston Otmoor.

Some people visiting the roadshow expressed frustration that Parkridge was not in attendance. Mistral explained that the roadshows were an impartial activity focused on gathering feedback, rather than detailed discussion of information that was not currently available, and encouraged everyone to fill in a questionnaire.

#### **Overall conclusions**

As already noted, the response rate for this consultation, although higher than average for similar exercises, does not exceed 10% of the possible respondents, whether to the pre-paid questionnaire or the roadshows, and is therefore an indicative rather than absolute reflection of the views of the local community.

Overall the results of the community consultation for the Weston Otmoor eco-town show that while support does exist for the scheme, the majority of respondents do not support the draft proposals shared during the consultation.

The highest percentage of support for the proposals was registered through the website with 26.5% of respondents accepting the need for more housing in the area, and thinking that Weston Otmoor is as good a place as any. Those responding online may be using this more anonymous route to express their support. Roughly one-third of those responding by pre-paid questionnaire or through the consultation website did not accept the need for new housing in the area, irrespective of its location. The highest percentage of opposition was registered at the roadshows with 90% of respondents disagreeing with the proposals. Those making the effort to attend roadshows were most likely those with the strongest views, and the strongest views are usually negative, rather than positive.

Those living closer to the proposed site are more likely to disagree with the proposals, while those living further afield are more likely to support the proposals or do not have a strong view.

Certain aspects of the eco-town are perceived by respondents as being beneficial: particularly the improved infrastructure such as the East West Rail Link and the improved junction with the M40, and the new jobs and (affordable) housing that the proposals will bring.



Common concerns cited over the proposals focus around increased traffic and congestion, and damage to the countryside, including the SSSI.

#### **Considerations**

In addition to considering the results above, and following detailed contact with statutory bodies such as Natural England and the Environment Agency; with officials from across Government including the Department for Communities and Local Government, the Department for Transport and the Department for the Environment, Food and Rural Affairs; local representatives at all levels of local Government; local community organisations and other stakeholder groups, Parkridge has received a range of feedback including suggestions on how to improve the proposals and concerns regarding them.

As the proposals have been further developed by the project team since the initial concept for the eco-town was discussed with stakeholders and local bodies a year ago, the key issues and concerns that have been raised have been addressed as follows:

- The Site of Special Scientific Interest further protection has been afforded to the SSSI to the south of the site
- The Green Belt housing development is no longer proposed in the Green Belt fringe
- Impact on Bicester and its regeneration plans to address the potential impact on Bicester, Parkridge has met with key organisations working on the ground to understand these concerns in more detail and has begun to develop ideas on how to mitigate the potential impact, and to articulate and explore where the proposals will support the economic development of Bicester.

Other concerns that have been raised can and will be addressed, assuming the project proceeds to the next stage. Outline responses are provided below.

- Transport infrastructure Parkridge believes that the early delivery of the rail link from Oxford to Milton Keynes, at a time when there is no certainty in terms of securing Government funding, can only support the long-term regeneration of Bicester. Furthermore, the rebuilding of Junction 9 of M40 will release capacity to enable Bicester's employment offer to grow, which is currently constrained by a lack of capacity on the junction
- Retail and employment considerations Parkridge is committed to exploring how the retail space at Weston Otmoor can be limited in overall amount, to ensure that day-to-day requirements are met, but that the higher order centres, including Bicester, are not threatened. For example, the size of any one retail unit at Weston Otmoor can be limited, so that the prospect of undermining provision at Bicester with the introduction of a superstore can be avoided. Similarly, the timing of the delivery of land for employment at Weston



Otmoor can be aligned to requirements and land release in Bicester, so that, if appropriate, Bicester can take first advantage of Weston Otmoor infrastructure

- The feasibility of the transport proposals the transport elements of the proposals have been further developed and discussed with Oxfordshire County Council, Network Rail, the Highways Agency, and the Department for Transport to ensure the transport proposals will deliver the desired level of modal shift and therefore to encourage people to use public transport rather than the private car and to ensure there is no negative impact on the existing road network. In addition, the proposals are being independently tested by transport consultants commissioned by Oxford County Council. Consultation responses expressing concern regarding traffic impacts means that work also needs to be done in communicating the nature of the proposals to the community at large; focusing particularly on how it will not have a negative impact on the existing local infrastructure
- Commercial viability of the scheme concerns have been raised that Parkridge is unable to
  deliver the infrastructure proposed within the eco-town. An independent financial assessment
  of the proposals is being undertaken by PwC (PricewaterhouseCoopers) which has been
  engaged by the Government to assess all of the short-listed eco-town proposals
- Request for further detailed information as the proposals are developed further information on all elements including affordable housing provision, types and numbers of schools and colleges, the provision of health and community facilities will be made available.
   Furthermore as the proposals are developed in more detail, Parkridge will take into account feedback received from local residents on the use of local roads such as access from Wendlebury to the A34 southbound.



#### 10 Next steps

The consultation website <a href="www.WestonOtmoor.co.uk">www.WestonOtmoor.co.uk</a> has been updated to include Parkridge's Final Bid Presentation (non-technical summary) in full and available for visitors to the site to download in PDF format. This community consultation report will also be made available online, and a follow up newsletter, in both hard copy and electronic format, will be produced and distributed. This will include an overview of the community consultation report and the answers to questions commonly asked during the consultation period.

If the Weston Otmoor proposal meets the challenges set, and is selected by the government in early 2009, the communication strategy will be further developed to support the ongoing development of the proposals in particular during the planning phase.

Many of the Phase 1 activities will be repeated to maintain community engagement, such as the community newsletter and feedback, and foster strong community partnerships as the plans develop. A range of additional activities will be used to gather a cross section of community views from within the sphere of influence of the proposed development.

These activities and their outcomes will be summarised in later consultation reports.





## Road toll and free trams in eco-town

ROAD tolls and a free tram service were among the proposals as a developer today revealed its draft masterplan for the proposed ecotown near Weston-on-the-Green.

After months of speculation and protest about the environmental impact of the 15,000-home settlement, the company behind the scheme has unveiled its masterplan for Weston Otmoor.

Parkridge, the developer, reveals there would be a single point of access into and out of the eco-town — and residents would be charged for leaving by car. The cost of this 'eco-town toll' would vary — rising at times when surrounding roads

were congested.
Residents of Weston Otmoor are Residents of Weston Otmoor are promised a free tram service around the 800-acre site, with every home within 300m of a tram stop. One proposal is to install real-time screens in every home and office, which would display the times of both the next tram and the current car toll charge.

A new rail station, servicing Oxford, Milton Keynes and London, would be built on the south side of the site, with ten trains per hour to Oxford and six to Bicester. A 6,000 space park-and-ride would be built next to it.

The developer says the eco-town would require the current A34/M40 junction to be entirely rebuilt.

The masterplan proposes that between 30 and 50 per cent of the 15,000 homes would be affordable.

Weston Otmoor would have a population of about 35,000, with 12,000 people working in the eco-town.

The scale of the project is reflected in the fact that the masterplan includes eight primary schools and two secondary schools. A report on the masterplan by a Government-appointed panel of experts was published this week. It calls on the developer to assess the implications for Bicester and the risk of Weston Otmoor becoming a commuter town. The panel also calls on the developer to address concerns about the tram system being downgraded to buses and to provide details on how road charging would be enforced.





Parkridge, the developer, is urged to refine its scheme to ensure the eco-town is a place where people will want to live and work, with the need to show how "the quality of life in Weston Otmoor will be different from a resident of Bicester".

But the report's main focus is on potential transport problems.

It says: "The transport strategy uses tram-train, free travel and demand management for car use. However, residents may simply take the tram to the park-and-ride and drive to London or Birmingham."

transport links to central Oxford, the John Radcliffe Hospital, BMW at Cowley

and A34 employment sites.

The developer is also told to demonstrate that the proposed high street running across the A34 is viable, and why residents would not travel to Oxford to shop. With a large part of the 800-acre site used as farmland, there is a recommendation to explain how the plans can maximise food production on the site and strengther biodiposities. strengthen biodiversity

Residents living close to the proposed site near Bicester questioned the pan-el's local knowledge.

Tony Henman, a spokes-man for campaign group Weston Front, said the pan-el's report was "fatally flawed" because members had not talked to locals or had not talked to locals or councillors. He added: "The report touches slightly on the sustainability of Bices-ter, but there is no mention of Kidlington, the Green Belt issue or the special sites of scientific interest." John Walker, chairman of the eco-towns panel, said: "Clearly there is still a lot of work to do."

"We have said that we will use local knowledge and experience wherever possible, to make Weston Otmoor a place that everyone can be proud of. Consultation with local people plays a big part in this."

Oxford is a city that is bursting at the seams it's like a pressure cooker. There are between 3,000 and 4,000 people on the city's social housing list and the same in Cherwell."

Mrs Flint met with city, district and parish councillors, as well as opponents of the proposed eco-town at Weston Otmoor.

Alan Cotton, a spokesman for protest group Weston Front, said flooding and transport worries made the proposal unsustainable.

He said: "The plans don't meet the objectives the housing minister has put forward for eco-towns."

But Oxford City Council leader Bob Price said: "We support the eco-town as we need for more housing in the city both for rent and to buy. The Weston Otmoor scheme would be on lowgrade agricultural land and it has a huge advantage in terms of access to current transport links and urban facilities.


The land shown coloured purple is a Site of Special Scientific Interest (SSSI), Its value lies primarily in its management as a traditional (wild flower) meadow within an unmanaged hydrological regime, Safeguarding of the SSSI requires:

- No public access
- Distance from development
- A maintenance of the ground water conditions

The plan demonstrates how details of the masterplan are being developed to deal with individual situations.

The 'buffer zone' will minimise disturbence by carefully managing public access and by providing extensive alternative areas for informal recreation. Substantial linkage is achieved to the flood plain of the Gallows Brook. This linkage also rejoins the two woodlands (County Wildiffe Sites and Ancient Woodland), Wormough Copse and Weston Wood.

The existing public footpath which crosses the SSSI may be diverted.



### Weston Otmoor: some myths explained

#### The development is in the Green Belt:

Only part of the developed area of Weston Otmoor is Green Belt – about 6.5%.

This represents about 0.125% of the Oxford Green Belt (less than 1/2 of 1%).


#### The development is on a flood plain:

Please see the Masterplan which shows the very limited extent of the Gallows Brook flood plain which, in turn, will be incorporated into the Masterplan as an environmental feature.

The development will add 25,000 cars to the A34: Vehicles added will balance with vehicles removed. Weston Otmoor's emphasis on high quality (FAST, FREE & FREQUENT) public transport will deliver substantial modal shift away from cars.

The development will completely choke J9 on M40: Junction 9 will be re-built to improve all movements, especially access to Bicester.

The development will destroy an SSSI: Please see Board 9; the SSSI will be protected and enhanced.








